Sewer Rate Increase, Beginning First Quarter 2021

Beginning first quarter 2021 sewer rates will be increasing:

	OLD RATE	NEW RATE
Single Unit	\$107	\$120
Double Unit	\$214	\$240

The rate increase was approved by the board to cover the increase in expenses to maintain and monitor the Village sewer system.

In addition, in early November the West Lift Station on North Packer Drive was replaced. The new lift station is replacing the existing station that was installed in the 1970's. It will also be equipped with a backup generator and transfer switch in case of emergency power outage. The Village Board has strived to keep taxes and fees low over the years but after nearly 50 years in service, this \$140,000 improvement to the lift station was required.

After welcoming my newest family member and spending some quality time with her, the Village Office is resuming normal office hours just in time for tax collection season.

**Please be aware the Office may be closed during these times because the clerk has other work related obligations.*

Taxes are being printed at the county and they will be going out in the next week or so. There will be another "Tax Newsletter" this year in each of the tax bills. It will have payment information and other Village updates on it.

The Office will be open during regular hours on December 24th and 31st to offer residents the opportunity to pay their 2020 property tax bill by December 31st in order to claim it on their 2020 income taxes.

2020 property taxes first installment or full payment is due to the Village Clerk by January 31st, 2021. Due to the continued public health emergency, please wear a mask when coming into the Village Office.
