

## FRANCIS CREEK VILLAGE UPDATE

### Winter Parking Ban

The village winter parking ordinance went into effect December 1<sup>st</sup>. Please do your part to keep village streets clear during the Winter months. The Villages Parking Ordinance reads as follows: There shall be No Parking on any streets within the Village limits from December 1 to April 1, between the hours of 1:00 a.m. and 6:00 a.m. In addition, there shall be no parking at any time if the roads have not yet been cleared of snow. The Village President may at any time during the year when snow conditions require, restrict or prohibit parking on any or all streets in the Village of Francis Creek as necessary.
